...on Commons

*“Commons are shared resources that are produced and maintained by a user community, according to their own rules and norms. This means a commons is defined by 3 aspects: 1) a shared **resource** 2) the **activity** of commoning 3) **rules and norms** that must at least be partially autonomous from the public and private sector.” - D. Bollier*

...on Timelab.org

Aims: city research lab creating new models of organizing, working and living through concrete prototyping as examples that generates trust and resilience. Open knowledge, peer-learning and a contributive attitude are the main characteristics of the Timelab way of life. ;)

Ecosystem: core staff (3), team (+3), contributors as volunteers commoners (+7), Board (5), community of makers (90), Core makers (10) Residents (6), Associates, networks of partners (local/regional/international in academia, culture, business, social economy, education, public and private ...), city institutions and public... - infrastructure/hardware and know-ware...?

Activities: Residencies, Festival/Bootcamp, Workshops, Weekly shared lunch on Friday, Lectures/debate/screenings, presentations, makerscafé, peerlearning, show & tell, Open lab (4 days a week) community (innovation) projects (ADEM, HAP, RUIMTE, RECYCLE BOT, KNOTPLEX), Processing/coaching on new community based and value driven business modeling.

Role within the flemish art network: function in the flemish landscape of the arts: development and reflection (not focused on 'production', nor 'presentation', nor 'participation'.)

The aim of the function '**development**' is R&D of the arts. Focus on experiment, process, self reflection, innovation in production, education, participation, communication, organisation. Life Long Learning for the artist.

The aim of the function '**reflection**' is art critics and stimulating reflection and making this accessible. The meaning of arts, an oeuvre or art in society are topics of discussion. The reflection focuses on artistic, cultural or art critical content and must aim at the contribution of knowledge on the development of the art scene or aims to strengthen the discussion about this development. There is always a publication, symposium, lecture or debate.

What is to (UNder)Common-ing in RESIDENCIES

(Timelab) residency as an experiment

REASONING:

- collecting/sharing/questioning knowledge (norms)
- Constantly altering process that is up for negotiation
- exchanging (marginalized) experience and (non-dominant) perspectives
- using resources of time and lab for interaction and innovation

RELATIONS:

- along different times/process-stages relations of all involved with residents are change (call commissioner, residency curator, core staff, board, community, associates, net, city...)
- ideally these changes should evolve as: fluid yet articulated, transparent and explicit
- in terms of values the '(un)commoning relations' should be: mutually generous (non-exploitative), inspiring (not just formal), careful (empathic) and authentic (honest)
- known issues with: (non) (accepted) applicants, (non) (clear) communication, (non)

PROCESSES:

- before

- Structuring the call for applications
- Announcing the selection (transparency)
- Defining Timelab's expectations
- Information on the place in english // Reflection on a common language (*you are not an artist if you do not speak English*) -- translation as an active process
- Converging structures and perspectives (different backgrounds and disciplines) - not stacking
- Parallel processes (multiple residences at the same time)

- during

- Link resident with Timelab's members (Introductory sessions, daily activity etc)
- Place for residents to present the progress of their work
- Inform resident on Timelab's ongoing projects
- Link between resident working together (or from different organisations)
- Connection to broader network

- Dissemination of outcomes (openness)

Re-Thinking/Co-Organising residencies as Commons

-- Vision for emerging A.I.R. programs --

During a 3 day meeting a group of artists and researchers in residence from various backgrounds got together at timelab (footnote timelab / timelab.org) to reflect as a “think tank” on possibilities, new models and methods of residency program that is to transform.

In relation to timelabs overall strategic interest in commoning and on *the Commons* the initial approach of this ad-hoc research session was based on a bottom-up approach - inviting artists to discuss the means of a program they would potentially use themselves.

*“Commons are shared resources that are produced and maintained by a user community, according to their own rules and norms. This means a commons is defined by 3 aspects:
1) a shared resource 2) the activity of commoning 3) rules and norms that must at least be partially autonomous from the public and private sector.” - D. Bollier*

We will summarize the departing points of this session and propose a model/vision for future AIR Programs as seen by participants in their individual or collective visions.

The key points are based on the following:

1. Spatial aspects

- a. Modular work / research space (inside existing infrastructure): adjustable for individual needs. Open for constant re-negotiation with other users of space.
- b. ‘Settlement’ as a model / spatial proposal for calibrating social interaction and processes of care in commoning (Vladimir Miller / <https://apass.be/settlement-1/>)

2. Converging structures

- a. Prevent stacking: overlay/intersect perspectives through a network of residencies with different backgrounds and disciplines
- b. Parallel processes.
Multiple residencies at the same time (reflecting on simultaneity and delay)

3. Transparency as a method of acting

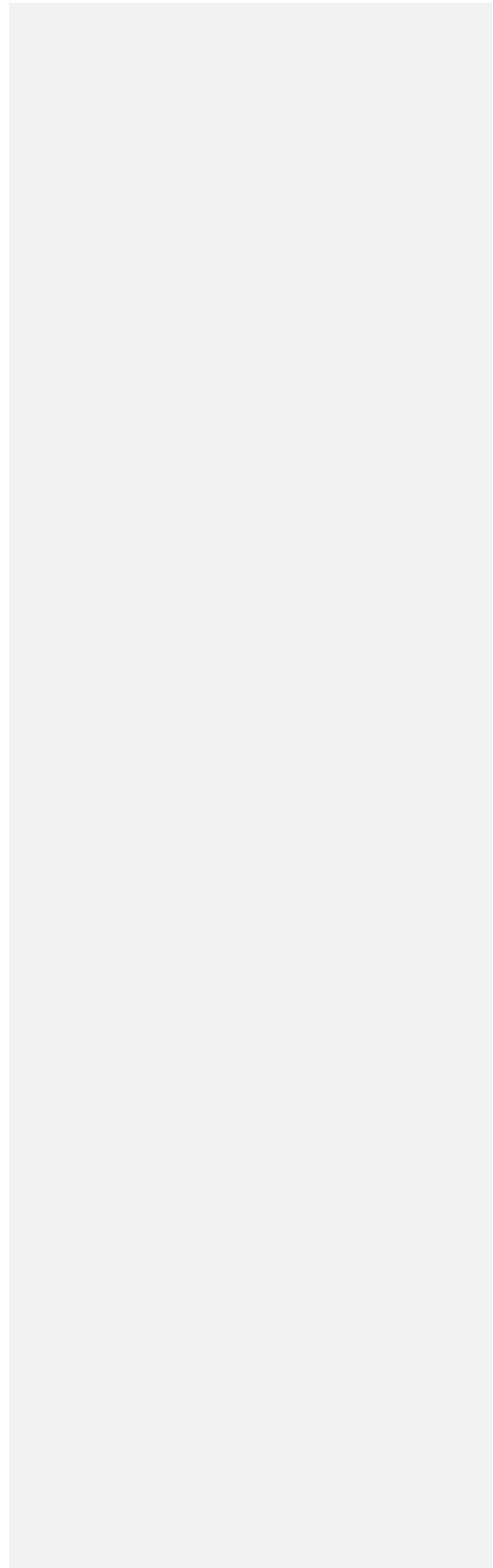
- a. Making all structural processes visible / public / accessible / shared
 - i. Application Process: Open call, detailed positive answer or refusal,
 - ii. Funding (how transparent can it be on all levels, online documentation)
 - iii. Expectations / reflecting on the process through routinely meetings // Dealing with “failure” - setting aims and goals
 - iv. Question any given need for production and documentation

4. Implementing commons structure in the planning process

- a. Constant re-negotiation of all structural processes. No fixed rules, just general guidelines
- b. Non-hierarchical system / bottom-up / flexible and resilient structures

5. Practical example / research proposal for timelab, Gent

- a. Basic organisational structure of Timelab vzw - incorporating residents
- b. Relational constellations with other city, regional and international partners

SUSTAINABLE CREATIVITY IN THE POST-FORDIST CITY

FWO 19 August 2015

The overall aim of this research is to gain theoretical as well as empirical insights into the urban conditions for sustainable creativity for both the 'classic' arts and the creative industry. Earlier research has shown that the urban context is the most important breeding ground for creativity. This study will address the social, economic and political conditions that cities (may) generate in order to develop a sustainable creative biotope. It revolves around such questions as: How do social conditions (for instance, networks, the creative class), economic conditions (for instance, competitive relationships, business models, creative commons), and political conditions (for instance, (cultural) policy, subsidies, democratic decision-making) affect urban creative biotopes? What kind of creative processes are viable, or not, under specific social, economic, and political circumstances? And, what are the 'needs' of artists and creative individuals or organizations to stay creative in the urban context?
